## UNCONDITIONAL GUARANTY OF ACCOUNT

Any notice provided under the terms and conditions of this paragraph shall be sent to Contractor Sales & Service, L.L.C., certified mail, return receipt requested.
3. This Guaranty shall apply to all indebtedness of said business to Contractor Sales & Service, L.L.C., and arising in the normal course of business.
4. This Guaranty shall cover the renewal of any claims guaranteed by this instrument or extensions of time of payment thereof, and shall not be affected by any surrender or release by Contractor Sales & Service, L.L.C., of any other security held by it for any claim hereby guaranteed.

**ANSWERS TO OUR MOST ASKED QUESTIONS  
WHEN SETTING UP A NEW ACCOUNT:**

- Contractor Sales and Service provides products and services to established credit accounts.
- Certificates of Insurance (C.O.I.) must be provided in all rentals.
- A damage waiver charge of 14% on the rental will be added to the invoice unless a C.O.I is provided in all other rentals. C.O.I.'s must be provided at time of rental.
- Rental rates and freight should be negotiated at time of rental to ensure customer satisfaction.
- Rental rates are based on (1) day / 8 hour, (1) week / 40 hours, and (4) weeks / 160 hours.
- Downtime or adverse weather, have already been established in rental rate structure.
- Machines will be delivered full of fuel and billed at a predetermined price per gallon if returned empty. Fuel rates may change unannounced with the volatility of the market.
- Customer must call to schedule a machine for pickup when completed, at which time, you will be provided, a pick-up # for your reference. We will not pre-release equipment.
